POLK COUNTY OVERVIEW AMERICAN RESCUE PLAN ACT

The American Rescue Plan Act (ARPA) passed by Congress and signed into law by President Biden on March 11, 2021, is a \$1.9 trillion economic stimulus package. In this law, state and local governments receive a total of \$350 billion in assistance. ARPA funds cannot be used to reduce property taxes.
